the Government of Manipur, imposing "Curfew" in several Districts of Manipur which is still in force without any relaxation in Imphal East District, and order dated 31st May, 2023 of the Home Department barring internet/data services including broadband in the State thereby rendering functioning of physical and virtual court not feasible for the time being, the cause lists dated 1st June, 2023 are hereby cancelled, except the items under Delivery of Judgment published in the cause lists in respect of both Division and Single Benches.
