



  - b. Item-wise cost of replacement components
  - c. Applicable taxes, duties and all other charges
3. All materials/components supplied shall be new, genuine and of approved make.
4. The work shall be completed within the stipulated time as decided by the Department in consultation with MSPCL.
5. Payment shall be released only after satisfactory completion of the work and **certification by MSPCL engineers.**
