1. Pay Scale: Rs. 5200-20200+Grade Pay: Rs. 2400/- per month and other allowances

2. Vacancies: 9 vacant posts of Computer Operator

3. Reservation: 5-UR(Unreserved), 3-ST, 1-OBC (M)

4. Nationality: Candidate must be a citizen of India

5. Age Limit : Not exceeding 38 years as on the last date of form submission

i.e. 10th September, 2015 at 11:00 p.m. relaxable by 5 years in case of

SC/ST and 3 years in case of OBC candidates.

#### 6. Educational Qualification:

- (1) Must be a Graduate (B.A./B.Sc.etc.) or equivalent examination from a recognized University as on the last date of form submission, i.e. 10th September, 2015 at 11:00 p.m. The Degree obtained through Open Universities/Distance Education Mode needs to be recognized by Distance Education Council (erstwhile)/Distance Education Bureau. Accordingly, unless such Degrees had been recognized for the period when candidates acquired the relevant qualification, they will not be accepted for the purpose of Educational Qualification.
- (2) Must have obtained Diploma/certificate in Computer Operation and must have received training for execution of works such as (1) Data entry and DTP works (2) Basic Hardware maintenance including installation of peripheral device; (3) Setting up and configuring LAN and (4) Using utilities and application software etc.

#### 7. How to apply:

Things to be kept ready before online form submission.

- a. Your own valid E-mail ID.
- b. Scan Copy of Matriculation Certificate.
- c. Scan Copy of Graduation Certificate.
- d. Scan Copy of Diploma/Certificate in Computer Operation.
- e. Scan Copy of SC/ST/OBC Certificate if applicable.
- f. Scan Copy of Recent Colour Passport Photograph (Size: 10-20 KB, Dimension 4.5 cm x 3.5 cm).
- g. Scan Copy of your Signature (Size: 5-10 KB, Dimension 5 cm x 3 cm with white background).
- h. Scan Copy of No Objection Certificate issued by concern authority if applicable.

## Application forms must be submitted only ON-LINE following the procedure given below:

- 1. In the official website of High Court of Manipur (<a href="http://hcmimphal.nic.in/">http://hcmimphal.nic.in/</a>), go to the link "Apply here for the post of Computer Operator".
- 2. Click on "Register Here".
- 3. Type in your valid E-mail ID, Contact Number, Gender and Password.
- 4. A Verification Code will be sent to your E-mail ID for verification.
- 5. Once you type in the verification code, you are registered for Online Form Submission.
- 6. Login using your given E-mail ID and Password.
- 7. Type in all the necessary details.
- 8. Upload all the necessary Scanned copies.
- 9. Click on the "Submit" button only after making sure that all typed in details are correct. (Once submitted, no changes will be entertained).
- 10. After the submission you will be guided to the payment gateway for online payment of examination fees. (Rs. 550/- for UR and OBC, Rs. 350/- for SC/ST candidates).
- 11. When the online payment is successful, **Admit Card will be auto-generated** to be printed out. Now the process of your online submission is **successful**.
- 12. A link of the Admit Card (for future references) and any other information will be sent to candidate's E-mail ID

#### 9. Scheme of Examination:

The recruitment process will consist of the following stages-

## Stage 1. Computer Typing Test - 50 marks

Candidates should have net typing speed of 35 words per minute as minimum speed and only the number of candidates in the ratio of 1:10 ( i.e. ten qualified candidates for one post ) will be eligible for Stage 2 (Skill Test).

\*\* The Computer Typing Test will commence from 26<sup>th</sup> September, 2015. Candidates are advised to look up on the Official Website for the date, time and venue.

Stage 2. Skill Test - 60 marks

## Syllabus for Skill Test

- Data Entry and Peripheral works.
- > Basic Hardware maintenance including installation of peripheral device.
- Setting up and configuring LAN
- Using utilities and application software

The number of candidates in the ratio of 1:3 (i.e. three candidates for one post) from the merit list prepared on the basis of total marks secured from the Stage I and Stage II test will be called for viva voce/interview

\*\*\* The date of Stage 2 Skill Test will be notified only in the Official Website.

Stage 3. Viva Voce/Interview: 40 marks

\*\*\*\* The date of Viva Voce/Interview for qualified candidates will be notified only in the Official website.

#### 11. Mode of Selection:

Final Select list will be prepared on the basis of total marks secured in the Computer Typing and Skill Test and Viva Voce/interview.
