In the shorthand test, about 80 words per minute will be read out to the candidates for five minutes and candidates to be eligible for the interview will have to correctly take down not less than 65 words per minute (and not less than 60 words per minute in case of SC/ST candidates). Transcription has to be completed within 45 minutes.
