No. HCM/D-42/2023-Estt.-I/ 2887/. : Applications are invited from willing and eligible candidates for engagement as **Verifiers (Meetei Mayek)** under the AI-Assisted Legal Translation Advisory Committee, High Court of Manipur. The engagement will be on a **Work from Home** basis.

1. Work Description: The empanelled Verifiers (Meetei Mayek) will be engaged strictly on Project Basis under the scheme of the AI-Assisted Legal Advisory Committee of the High Court of Manipur to examine the correctness of the Meetei Mayek scripts of the translated judgments of the Hon'ble Supreme Court of India and Hon'ble High Court of Manipur and making such corrections as may be required for the purpose of ensuring correct spelling, etc.

## 2. Eligibility Criteria:

- ➤ A Master's degree in Manipuri (Meetei Mayek) with proficiency in English and computer applications.
- Proficiency in typing Meetei Mayek script using appropriate software and tools.
  - Preference will be given to candidates holding a law degree and prior translation experience.
- **3. Remuneration/wages:** Verifiers (Meetei Mayek) will receive remuneration at the rate of Rs. 30 per page (based on the number of pages in the original English judgments).
- 4. Age Limit: There is no age limit.

## 7. No Objection Certificate:

Applicants who are currently employed under any Government organizations must submit a No Objection Certificate from the concerned Authorities and a copy of the same should be submitted at the time of Personal Interaction.

#### 8. Mode of Selection:

- ➤ A Written Test in which a candidate is required to transliterate a translated judgment in Roman Script (of approximately 800 words) into Meetei Mayek.
- > Shortlisted candidates will be called for Personal Interaction.

- The empanelment of Verifiers will be strictly performance-based, with continued inclusion contingent on meeting the required standards. Failure to adhere to these standards may result in de-empanelment at any stage of the project.
