LOUKHIBA WAREP: 1.1. Ahanba mapuroiba leikhidraba matung da mama aduna angang adugi oifam thokpa amadi ain gi mityengda oifam thokpa ngakpi-senbinaba amata ngairaba meeoi oibanina, mama aduna angang adubu mahaak ki anouba emung aduda punsinba amadi mahak ki yumnaak leppibada ain na yaba maongda athingba piba yabru haibadu udaba yaore. 1.2. Wayelgi warep kakpinaba wakatlakliba meeoi adugi mapuroiba bu poktaba mapa ni haina kagaj singda hapnaba High Court na piba yaathang adu tamthiba yaathang amani amadi maduna angang adugi wakhal gi fibam amadi masagi ijat ta cheitheng pigani haiba khanthadaba yaathang amani. 1. Wayel gi gi warep kakpinaba wakatsing ashi mayok yaribasingna thaba F.C.A. No. 236 of 2011 amadi wayel gi warep kakpinaba wakatlasingna thaba F.C.A. No. 403 of 2012 da tarikh 24.01.2014 da High Court of Andhra Pradesh na

pikhiba maanaba amadi aroiba warep adubu shingnaduna tharakpani. Wayel gi warep kakpinaba tharakpa wakatshing ashida angang gi mama amadi angang gi leikhidraba mapa gi mama-mapa sing gi marakta yetnariba si angang duda piba yumnaak ki mataangdani. Unabagi hak su wakatche da hapi amadi court ta su yetnakhidre maram aduna hiram ashida High Court na pikhiba warep adu eikhoina khannadre.

Tentakpa wari

2. Wayel gi warep kakpinaba wakatliba meeoi aduga mayok yaariba singi machanupa, Konda Balaji ga 18.12.2003 da luhongkhi. Luhonglaba matungda angang ama 27.03.2006 da fangjakhi. Adum oinamak, wayel gi warep kakpinaba wakatliba meeoi adugi mapuroiba adu 14.06.2006 da leikhide. Matam aduda angang adu supna gi chahi 2 tangkhai khak ta surammi. Adugi matungda, wayel gi warep kakpinaba wakatliba meeoi ga IAF ta Wing Commander oiba Sri Akella Ravi Narasimha Sarma ga 26.08.2007 da luhongkhi. Luhonglaba matung da matei-manao anigi macha ama fangjaduna punna leiminari. Houjik angang, Master Ahlad Achintya ashi chahi 16 ka tha 4 khak suri amadi ain gi mityengda angang oiri.

3. The Guardian and Wards Act, 1890 gi Section 10 gi makhada respondents na makhoibu wayel gi warep kakpinaba wakatlakliba meeoi gi machanupa, Master Ahlad Achintha gi ngakpi-senbigadaba meeoi oina khanbinaba wakat ama 9th April, 2008 da tharami. Wakat adu thaba matamda, angang adu chahi 2 mukta ngairami aduga mayok yariba meeoi shingna mkha da piriba sing pibinaba nirakkhi:

- a) Wakatliba meeoi singbu ain gi thongda angang oiriba ming oina pallabada Ahlad Achintha hairiba chahi 2 suraba angang ashigi masa ngakpi-senbinaba gidamak ta khanbiba.
- b) O.P gi wakat gi aroiba rai tadrinpei marakta angang adu unabagi ayaba pibiba.
- c) Wakat ashigi achangba peisa.
- d) Hon'ble Court na wathok ki fibam amadi achumba wayel gi yengaga matik chai amadi maram chai khanba atei-atei mateng natraga matengsing.

4. 20.09.2011 da takhiba yaathang amada Trial Court na mayok yariba meeoishingna thakhiba wakat adu kakkhi amadi angang adubu mamagi nungshiba amadi cheksinna-luna toujaba adudagi khaidoknaba haibasi maram chade haina mot pikhi. Trial Court na mayok yariba mapu-mathou adugi ahal oiraba chahi adubusu khannakhi. Adumakpu, Court na mayok yariba meeoishingda angang adu unaba gi ayaba pikhi amadi wayel gi warep kakpinaba wakatlakliba meeoi amadi mahak ki mapuroibada makhoigi angang adu Hyderabad ta leiba mahakki mama-mapa gi yumda tha 3 loirakpa khuding gi yarimakhei di Dussehra, Deepavali amadi Sankranthi kumhei gi numitsingda amadi school gi suti thaba matamsingda puraknaba yaathang pikhi. Mayok yariba meeoisingbu makhoi gi masu nupa du hairiba matam sigi manungda numit 2 nong nganba dagi numit taba matam faobada unabagi ayaba pikhi.

5. Nakal animak na Trial Court na pikhiba yaathang adubu High Court ta thangatlakhiba wayel gi warep kakpinaba wakat singda shingnarakhi. Yetnarakpa matam da angang adugi yumnaak tu Konda da gi Akella da hongkhibani haiba High Court na Khanglakkhi. High Court na wakat ki aroiba warep tarikh 24.01.2024 da amata oina manana piraduna makhagi yaathang sing ashi pikhi:

- a) Wayel gi warep kakpinaba wakatlakliba meeoi haibadi Akella Lalitha na angang adugi oifam thokpa ngakpi-senbigadaba meeoi oigani adubu mahakna angang adu mayok yaribasing gi mayumda ningtham gi suti thaba matam da numit 2 makhoiga leiminanaba purakadabani. Mayok yaribasingna hana pao faonaraga su angang aduga unaba yagani.
- b) Yaathang ashi gi nakal ama fangba numit ta gi tha 3 gi manungda wayel gi warep kakpinaba wakatliba meeoina angang gi yumnaak amadi mapagi yumnaak hanagi maongda hanjilhanaba gidamak toufam thokpa chatnabi sing adu loisingadabani.
- c) Angang adugi mapa khannarakpa matamda chejan da utpa yarimakhei apokpa mapa gi maming utkadabani natrabadi Ravi Narasimha Sarma gi ming bu poktaba mapa oina utkadabani.

6. Ahanabgi khannaningai waram adubu khannaraduna, makha-thongba taba court animak na maanaba mot pikhi madudi mapa leikhidraba matungda mama na angang adugi oifam thokpa mabu ngakpi-senbigadaba meeoi oi.

7. Hindu Minority and Guardianship Act, 1956 ki Section 6 ki matung inna mkhagi ain oiba gi wafam sing piri:-

*“Angang oiriba Hindu amagi masa amadi mahaakki lan-thum (mahakki apunba emung gi yenthoknadriba lan-thum yaodana) bu ngakpi-senbigadaba oifam thokfam meeoisuingdi – (a) nupamacha oirabadi natraga yum pandribi nupimacha oiragadi, **ahanba da mapa na, mathangda mama na oigani:** toubatabu chahi 5 sudriba angang di mahousana mama ga leigani; (b) lannana pokpa nupamacha natraga lannana pokpa yum pandribi nupimacha oiragadi, ahanba da mama na oigani, mathangda mapa na oigani; (c) **yum palaba nupi oiragdi mapuroibana oigani.”***

8. The Hindu Adoption and Maintenance Act, 1956 ki **Section 9(3)** na piriba ain gi oiba wafam di,

“9(3) Mapa leikhidraba ntraga mapa aduna sangsar gi apamba thadokhraba natraga Hindu dharma chatpa

lepara natraga matik leiba Court na ngaore haina laothokhiba taragdi, mama na angang adu atopada yoknaba pithokpa yai.”

9. *Githa Hariharan and Ors. vs. Reserve Bank of India and Ors.*¹ ki wathokta, Court asina mamabu pikliba angang gi oifam thokpa ngakpi-senbigadaba meeoi ama oibagi hak adu the Hindu Minroity and Guardianship Act, 1956 ki Section 6 ki makhada piraduna, mapa gi thak ka manana wangkhathankhi.

10. Mahakki ahanba mapuroiba leikhidraba matungda, angang adugi amata ngairaba oifam thokpa ngakpi-senbigadaba meeoi oiriba mamada angang adu mahakki anouba emung gi manung chalhanduna angang dugi yumnaak leppibada ain gi oiba maongda matou karamna athingba piba yabage haibasi eikhoina uba fangde. Yumnaak ama haibasi meeoi amaga mahaaki emung gi atopa meeoishinga manana leiba ming amani, meeoi aduda thonba ming natraga ming sing dagi tonganba; emung dugi ming amani. Yumnaak haibasi paari-puri takpa, itihas ki, naat ki amadi paari-puri gi oiba maaongda khak khangnaroidabani adubu henna maru oina yumnaak na louriba thoudang ashi samaj ki asengba aduga mari leinana ni amadi angang singna magi-magi yum da angang oijabagi faoba eehul aduga mari leinana ni. “Emung’ semduna thamnaba, mangdana thamnaba amadi uhanaba gidamak ta emungdugi yumnaak manahanbani.

11. oihanbada natraga angang adubu mahaakna mapuroibada yoknaba pirabafaoda karisu akaiba amata ude.

12. Angang ama yokpa si chatnahanaba gidamk dalil ama darkar tade amadi madu leiriba chatnabi gi khuthangda touraga chatnahanba yarabsu, houjik khannariba wathok ashida wayelgi warep kakpinaba wakatlakliba meeoi aduna hai madudi 12th July, 2019 da houjik ki wakat ashi gi rai tadrinpei da wayel kakpinaba wakatlakliba meeoi ashigi mapuroiba/ angang adugi poktaba mapa na angang adu ming challaba dalil ama enaraga yokhibani. The Hindu Adoption & Maintenance Act, 1956 ki Section 12 na ain gi oiba wafam oina piri madudi “*Ayokpa angang ama si hiram khudingmakta yokpiriba mapa natraga mama gi macha ama oina mabu yokpa houba numit ta gi lougani aduga sigumba numit ashidagi houraga angang aduga magi pokfam emung duga leinaba mari khudingmak tatnare haina lougani amadi adugumba maridu mabu yokpiriba emungduna yokpiriba emungduda sembiba marisingna oina mahut singadabani.*”

13. Encyclopedia of Religion and Ethics ki matung inna, “*Angang ama yokpa haibasi angang adu haanagi ee-gi mari thoknaba meeoisng dagi anouba meeoi da pikhiba adubu khangnei. Angang adu pokfam oiriba emung adugi sadashya ama oiba tokani. Angang adu mahakki apokpa mama-mapa amadi ee- mari leinaba meeoisng ga mari leinaba hak amadi mathou khudingmak manglagani. Anouba emung aduda, angang adu nouna poklakpa, makhal khuding gi hak amadi thoudang khudingmak yaona mafam aduda pokpa sadashya amagagum oigani.*” Maram aduna, ashigumba angang amana yokpiriba emung adugi asengba sadashya ama oiraklabadi, mahakna mabu yokpiriba emungdugi yumnaak louba haibasi maram chai amadi sigumba wafam amada ain gi oiba khut thinjinba haibasi chamamnaba pokhalli.

Houkhiba matam dadi meeoi amana kanagumba ama yokpa si meeoi adu potloibinaba meeoi ama thamanabani amadi meeoi adugi pari-puri gi chada-naoda samtharakpa adu manghandana thamanabani, adubu houjikaandi anouba matam da angang yokpagi wakhallon asina kanagumba angang amana mahaaki pokminaba (ee na mari leinahanba) meeoisng ga leiminaba fangdraba matamda amuk emung-manung ga leiminabagi punsi-mahing adu hanjilhanaba pandam thami. Maram aduna, mathakta neinakhriba mayamsi yenglaga,

Anisubagi khannaningai oiba waram khannarakpa matamda, mayok yaariba mapu-mathou sing gi thengnariba awaba fibam aduda Court na nungsiba faoe adubu angang adugi yumnaak adu ahanba mapuroiba/mayok yaribasingi machanupa gi yumnaak ta hondoknaba karigumba mateng amata nirakhiba leite haibasidi achumba wafam amani. Wathok ki jaban da nijaraktaba mateng di piroidabani haibsi yanaraba ain ni. Wathok ki jaban da natraga nijabada yaodaba mateng ama court na khannaraba natraga piraba amadi mayok yaribasingna madugumba mateng adubu yetpagi natraga thingbogi tanja pidrabadi, court na achumba wayel touba ngamdaba oirakani.

16. **Messrs. Trojan & Co. Ltd. Vs. Rm.N.N. Nagappa Chettiar²** ta Court asina naakal amana niraktaba mateng piba yabra, adusu maram chana wathok ki jaban thamdana, haiba waram ashi khannakhi. Court na makhagi warep ashi loukhi:

“Wathok amagi warep ama loubasi wathok aduda saruk yariba kangbu sing na wathok adugi thamba jaban nataba da yengalaga louba yade haibsi yanaraba ain amani amadi thamlakliba wathok ki jaban aduni thigadabasi. Wakat che adu semdoktana, Court na nijaraktaba mateng ama piba gi hak leite amadi wakat che adu semdoktuna nijahoudaba mateng adu tongana hapchinjage haina nijarakkhibus leikhide.”

17. **Bharat Amratlal Kothari &Anr. Vs. Dosukhan Samadkhan Sindhi & Ors.³** ta warep ashi loukhi:

“Aningba-apambagi matung inna na mateng pibagi pak-chaona Court ta hak lei adubu mateng pibagi leijariba niti-niyom singbu udana amadi nakan da thamlaga wakatliba meeoi aduna nijaraktaba mateng ama pibadi ngamde.”

18. Wakat ashida angang adugi yumnaak hongdoknaba piba yaathang adu High Court na wathok adugi jaban da

nijarakpa warolsing da gi henjinna pire aduna mashina maram oirga ashigumba yaathang ashi kakthatpa yai.

19. Wafam ashiga khainadringei, ningjing-mangjingnaba poktanaba, amuk hanna hairi madudi mama adu khaktana oifam thokpa angang adugi ngakpi-senbigadaba meeoi oibana mangonda angang adugi yumnaak lepchabagi hak lei. Angang adu yoknaba pikhinabagi haksu mangonda lei. Karigumba mateng ama chap chana nijarabada khak Court ta khut thinjinbagi sakti adu leiba yai aduga adumaina nijaba warol adu angang adugi yaifanaba gidamak henna maru oina khallaga oigadabani amasung maduna atei khannaba yaba khudingdagi henna maru oiraba mtamda oigadabani. Mathakta khannakhriba mayamsi yenglaga , angang dugi yumnaak ka mari leinana High Court na pikhiba yaathang sing adu kakthatlae.
