**LOUKHIBA WAREP:** 1. Apunba thoudok adu khanghoudana thokkhibani. Bulb adu kadaiwaida thaangani haiabgi mataangda mapaa amadi machanupi gi marak ta khatnakhi. Khanghoudana amadi khudakki oina khatnaba adu da, wayel kakpinaba wakatlakliba meeoi aduna machanupida chimney gi thaomei ama langlammi. Thoudok adu khudakki oina thokkhibani amadi haana

thouraangkhiba leite. Chaaktuna leiba chimney gi thaomei adu wayel kakpinaba wakatlakliba meeoi aduna na loukhatлага leikhidrabee meeoi aduda langlammi. Thoudok adu khanghoudana khatnabada thokkhibana amadi haana thourangba leikhidabana, maral siraklaba meeoi adugi thouwong adu section 300 da yaoroidaba kaanglup 4 gi manung changani. 2. Wayel kakpinaba waakatlakpa meeoi-maraal siraklaba meeoi adu section 302 IPC gi makhada maraal leire hairiba adu Section 304 Part- II IPC gi makhada oina oigadabani haina semdokhi. Wayel kakpinaba waakatlakpa meeoi-maraal siraklaba meeoi adu keishumshangda chaorakna chahi 11 ga tha 8 muk leikhre. Wakat ashigi wafam amadi fibamshing amasung wayel kakpinaba waakatlakpa meeoi-maraal siraklaba meeoi aduna keishumshangda leikhriba matam adu yenglaga, keishumshangda leibagi dandi adu haana leikhraba matam adu oigadabani haina semdokhi. 2. Wayel kakpinaba tourakpa waakat ashi tarikh 11.04.2013 da Bilaspur da leiba High Court of Chhattisgarh na Criminal Appeal No. 587 of 2008 ta wayel kakpinaba waakatlakpa meeoi bu IPC gi Section 302 gi makahada maraal leire haiduna mahaaki mathakta punsi chuppagi keishumshangda thamnaba fadok taduna pikhiba wayel gi warep amadi yaathang adu High Court na su chummi haibadagi laakkhibani.

3. Ain gi thongda waakatlakliba meeoi gi wari di tarikh 23-05-2007 gi pung 7:30 PM taba matamda leikhidrabi Lalita du mahaakki kaa da mamanabi Dev Kumari (PW-1) ga famminarammi; aduga mahaakki mama Indra Kunwar (PW-2) na yumdugi manungda chaak-esing thongduna leirammi haibani. Matam aduda, wayel kakpinaba waakatlakliba meeoi-leikhidrabi adugi mapa aduna machanupi gi kaada changlakлага bulb adu louthokaga bulb adu sumaang da oina thaanolagae haina hairammi. Leikhidrabi meeoi ashina mahaakki apokpa mapa Govind Singh da bulb adu louthoktanaba hairabasu, wire adu louthoklammi. Leikhidrabi ashina amuk hanna wire adu samjinba houbada, wayel kakpinaba waakatlakliba meeoi asina wire adu samjindanaba haiduna tathina cheirammi, madudagi wahei-wata kaya hainaduna khatnarammi. Saobadagi wayel kakpinaba wakatlakliba meeoi-maraal siraklaba meeoi ashina chaaktuna leiba chimney gi thaomei adu leikhidrabi Lalita da langsillammi amadi mahak mei na chakapadgi asokp- apan nanghalammi. Leikhidrabi adugi laoba-khongba gi khonje tabadagi mahaakki mama (PW-2) amadi mahaakki mamanabi Dev Kumari (PW-1) mahaakki manakta khongje yaangna chensilammi. Ram Dayal (PW-4) amadi Mannu (PW-3) na leikhidrabi aduda esing heijinduna mei adu muthatlammi. Madudagi, khudakta leikhidrabi adu Odgi da leiba Community Health Centre da purammi amadi Dr. P.K. Patel (PW-9) na layengkhi. Ahanbagi layeng khara chatharaba matungda leikhidrabi adu Ambikapur da leiba District Hospital da thaarammi. Mahaak Ambikapur da leiba District Hospital da layeng chatharingei da tarikh 30.05.2007 da asokpana maram oiraga leikhide. Ahanbada thoudok adu IPC gi Section 307 gi makha da ming challaba matungda konna IPC gi Section 302 gi makha da oina semdokkhi. Leikhidrabi aduna siramdaida fongdokpa mahaakna sibagi maram piba wafam (Ex. P-16) adu PW-21 oiriba Executive Magistrate na leikhidrabi aduna wafam adu fongdokpa matamda mahaki wakhal-gyaan gi fibam da akaiba leite haina saktakche pikhiba Dr. P.K. Patel (PW-9) gi mamangda jabaan loukhi. Mitna uhouna sakhising, Dev Kumari (PW-1), apokpi mama Indra Kunwar (PW-2), Manu Singh (PW-3) amadi Ram Dayal (PW-4) na wakatlakliba kangu gi waridubu sougatkhide amadi sakhi oibagi jabaan pibada mamai leikhi. Leikhidrabi aduna siramdaida fongdokpa mahakna sibagi maram piba wafam (Ex. P.16) aduda maru oina yenglaga, trial court na wayel kakpinaba wakatlakliba- maraal siraklaba meeoi adubu IPC gi Section 302 gi makha da maraal leire haikhi amadi

mapunshi chuppa keisumshangda thamnaba fadok pikhi. Wayeli kakpinaba wakatlakliba meeoi adubu IPC gi Section 302 gi makhada maraal leire hairiba amadi mapunshi chuppa gi keishumshangda thamgadabani haina fadok takhiba adu High court na yakhi. Pendaba dagi, wayel kakpinaba wakatlakliba meeoi ashi eikhoi gi maangda lakpani.

4. Eikhoigi tarikh 10.08.2018 gi yaathang na supnatangi chathakhiba ain gi mityengda maral leiba thabak ki mashak-mawong amadi dandi gi chaang gi matangda khanghankhi.

5. Eikhoina wayel kakpinaba wakatlakliba meeoi/maraal siraklaba meeoi gi damakta leplibamadi State of Chattisgarh gidamak ta leplibamadi khang heiraba wakilsing gi warol tare amadi singnaraklaba wayel gi warep amadi chejan leiba atei che-chang sing kupna amadi yamma cheksinna pare.

6. Thoudok adu pung 7:30 P.M. taba matamda thokkhibani. Leikhidrabi aduna magi mamaanabi- Dev Kumari (PW-1) ga wari sanaringei, wayel kakpinaba wakatlakliba meeoi/maraal siraklaba meeoi aduna sumangda thangae haiduna bulb adu louthoknaba toubadu leikhidrabi ashina yaroi haina yetkhi. Wayel kakpinaba wakatlakliba-mapa amadi mahakki machanupi-leikhidrabi anigi marakta wahei gi oiba khatna-cheinaba thokkhi. Waheigi oina khatna-cheinaba aduda wayel kakpinaba wakatlakliba meeoi-maraal siraklaba meeoi aduna leikhidrabi aduda chimney gi thaomei langsinduna mei chaktuna asok apan nanghankhi. Mahak mai, thabaak, puk amadi faigan gi makha thangba sarukta sokkhi. Asokpa aduna maram oiraga mahak thoudok adu thokpa matung numit 7 leiraga leikhide.

7. Thoudok mapum adu khanghoudana khudakki oiba maong amada thokhibani. Bulb adu kadaiwida thangani haibagi matangda mapa amadi machanupi gi marakta khatnakhi. Khanghoudana amadi khudakki oiba khatnaba aduda wayel kakpinaba wakatlakliba meeoi aduna machanupi aduda chimney gi thaomei langsillammi. Thoudok adu khudakta thokkhibani amadi haana thourangba leikhide. Thanduna leiba chimney gi thaomei adu wakatlakliba meeoi aduna loukhatлага leikhidrabi aduda langsillammi. Khanghoudana thokkhiba khatnaba oibana amadi haana thourangba leikhidabana, maraal siraklaba meeoi adu gi thouwong adu Section 300 da yaoroidaba kanglup 4 gi manung da changani.

8. Section 302 IPC gi makhada wayel kakpinaba wakatlakpa meeoi/maraal siraklaba meeoi aduda pikhiba maraal adu Section 304 Part II IPC gi makhada da oina oigadabani haina semdokkhi. Keishumshang gi praman-che gi matung inna, tarikh 26.08.2017 da wayel kakpinaba wayel kakpinaba wakatlakliba meeoi/maraal siraklaba meeoi adu keishumshangda chahi 10, tha 2 ga numit 25 leikhre. Houjikfaobada, wayel kakpinaba wakatlakpa meeoi/maraal siraklaba meeoi adu chaorakna chahi 11 ga tha 8 muk keishumshangda leikhre. Hairiba wafamsing amadi wakat ashigi fibam shing amadi wayel kakpinaba wakatlakpa meeoi/maraal siraklaba meeoi na hana keishumshangda leikhraba matam ashi yenglaga, keishumshangda leibagi fadok ki matam ashi haana leikhraba matam ashi oina oihallae.

9. Section 302 PC gi makhada wayel kakpinaba wakatlakpa meeoi/maraal siraklaba meeoi ashibu maral leire hairamba adu Section 304 Part II IPC gi makhada oina maraal piire. Wayel kakpinaba wakatlakpa meeoi ashida punshi chupa keishumshangda thambagi piba dandi adu wayel kakpinaba wakatlakpa meeoi/maraal siraklaba meeoi aduna keishumshangda haana leikhraba matam aduda oina hanthare. Atoppa wakatki damak masa lakpa darkar tadragadi, wayel kakpinaba wakatlakpa meeoi/maraal siraklaba meeoi ashibu khudakta thadoknaba yaathang piri.

10. Mathakta pankhriba sart shing ashida wayel kakpinaba tharakpa wakat ashi gi saruk khara yare.
