Makhoina chatkhraba matungda PW-1 amasung mache/manao upi yumdudagi laoduna chenthoklakkhi. Kholaodu taabada khunggangdugi missing amasung maral leire hai chennariba thunglammi. PW-1 amasung mache/manao upi duna maral lei haina chennariba misingdu ubada paakhalammi. Maral leiriba misingduna mihat mipun touramliba misak khangbra hangba matamda PW-1 amasung mache/manao upi duna kibagi maramna misak khanghoudre haina khumlammi. Atung tarakpada Investigating Officer wahang paokhum mataang laakpada PW-1 maral lei haina chennariba mioisingdugi maming matha pankhibaga loinana maral lei haina chennariba mioisingdugi mathakta charge-sheet pansinkhi. Trial Court aduna khudamsing adugi maramda kupthana khantharaduna maral leiriba missing aduda sibagi dandi pikhibakhak nattana hanthaba maralgi dandising pikhi. Trial Court ki wareptuda pendaduna maral leirabasingduna High Court ta case tu pukhatlammi. Trial Court na tarakliba warep aduda High Court nasu yaningba phongdokkhi. Adumoinamakpu appeal tourakpagi matung inna High Court na sibagi dandidubu punsichuppa keisumsangda thambagi dandida onthokkhi. Mihat-mipungi thoudok aduda PW-1 asi siktuna hinghouba sakhi. Maram aduna PW-1 na court ta serannaba sakhi pibagi wapham leite. Adugisu mathakta wahang-paokhum gi matamda mahakna pikhiba paodamsingda chingnaningai oiba natraga paokhum maanadaba amata yaokhicle. Section 161 CrPC gi matung inna PW-1 na pikhiba paokhumsingga cross-examination da pikhiba paokhumsingda chaanadaba, case pu sonthahannaba natraga mahakki paodamsingbu kakthatnaba karigumba amata phangkhicle. Maram aduna mahak asi thoudoktugi achumba warol puthokpa thoudok adugi asengba sakhini. Thoudoktu loisillakpa tanjada khungganggi miyamna PW-1 hangkhiba matamda PW-1 maral lei haina chennariba misinggi maming matha pankhidabadu aphaba cheksin-thourangni haikhi; maramdi maral leiriba mising adu makhoigi anakpa mari-matani aduga tanjaduda PW-1 maral lei haina chennariba misinggi maming matha pankhidabadu mapunsi kanjanabani.

Adugisu mathakta wahang-paokhum gi matamda mahakna pikhiba paodamsingda chingnaningai oiba natraga paokhum maanadaba amata yaokhicle. Section 161 CrPC gi matung inna PW-1 na pikhiba paokhumsingga cross-examination da pikhiba paokhumsingda chaanadaba, case pu sonthahannaba natraga mahakki paodamsingbu kakthatnaba karigumba amata phangkhicle. Investigating Officer na statement lounabagidamak hospitalda chattuna wahang-paokhum touba matamda makhoina thokkhiba thoudoksing adu arik chumna, mathang manao naina phongdokkhi. 3. FIR pallakpagi matung inna thijin-humjinnaba huigi squad sijinnakhi. Squad tuna mathou chap chana paangthokkhi. Matamdua mihatpada chennariba maming-matha pankhidabagi maramna huigi squad

tuna mihatpasingbu sakkhangkhide. FIR pallakpa atamduda PW-1 hospitalda admit touduna leirammi aduga PW-1 maral lei haina chennariba misingdu kanano haibadu mapunsi kannaba maram chaana phongdoklamdri. [Para 20][940-B-C]

4. PW-1 gi mache/manaonupi amasung 'H', 'V' gi mapada wahang-paokhum toukhidabasu maram chai. Prosecution asida makhoigi paodam taadabana case asigi maral leiba adugi chap chaba khudam-praman da maru oiba mateng oide. Maramdi sakhi pibada darkar oiribadi sakhidugi achumba warolduni, sakhi piba mi masing natte. PW-1 asi phibam thina soklaba, sihoudraba, mihat-pipungi thou-ong aduda sihoudraba sakhini. Aduna section 164 CrPC gi makhada PW-1 gi mache/manaonupi amasung 'H', 'V' gi mapada wahang-paokhum toukhidabasina courtki warepta khennaba leihande. Section 164 CrPC gi makhada wahang-paokhum toubasi Investigating Officer gi mathouni. Aduda mahakki lousing sijinaduna section 164 CrPC gi makhada PW-1 nataba atoppada wahang-paokhum toukhidabodu darkargi matung inna mahakna sijinaba hakni. [Para 21, 22][940-D-E]

Party animakki learned counselsinggi warolgi matung inna Ajai alias Aju leikhidre. Criminal Appeal No. 598, 2013 da aonba leikhidre. Criminal Appeal No. 337, 2014 asi maral lei haina chennaraba Mukesh na thanggatlakpani.

2. 22.02.2012 da mathakki wakatsing asi High Court ta Trial Court na Indian Panel Code1 gi section 302/149 gi amasung IPC amasung Arms Act, 1959 gi makhada pirakkhiba sibagi dandi dagi ngakpinaba amasung warep chumthokpinaba nijarakpagi matung inna punsi chuppa keisumsangda leibagi dandida onthokkhi. Atoppa warep singdadi aonba leite.

3. 2015 gi Criminal Wakat Nos. 745-748 si State of Uttar Pradesh na maral leiraba mioi 4 bu High Court na punsi chuppa keisumsangda leibagi dandida onthokkhisi sibagi cheirak pinaba yathang pirakkhi.

4. Case asi samlapna yenglabada maral leiraba Braj Pal Singh na Muradnagar, District Ghaziabad tang 25.08.2007 gi 4.30 AM tabada wakat ama thanggatlakkhi. Madudi, ayukki pung 3.00 rom taabada mahakki mayamba/manaonupa Vijay Pal Singh gi macha nupi Ms. Rashmi na lao-khonglakpa taakhi. Lao-khongbadu taarabada mahak amasung khunggangdugi mioi kharana yengsillubada mahakki mayamba/manaonupa Vijay Pal Singh, mahakki nupi Smt. Rajesh ground floor da leiba phamungda athouba khutlaina mangak lenthattuna siraga leirammi. Mahakna mathak thangba floor da kakhatlubada Vijay Pal Singh gi macha nupa Nishant, mayanupa Mangal Singh su mangak lenthattuna siraga leirammi. Vijay Pal Singh gi macha nupi Smt. Pinky su ground floor da thina soktuna leirammi. Mahak hospital da athubada pukhatkhi aduga asiba hakchangsingduna leirampham duda asum leihoui. Case registered touraba matungda thijin-humjin houjinkhi.

5. Siduna leiramlaba Vijay Pal Singh gi machanupising Ms Rashmi amadi Smt Pinky (PW-1) bu Investigating Officer na wahang-paokhum touduna thoudoktugi akuppa warol loukhi. Makhoigi waphamgi atung inna kinigai oiraba thouongsinggi akuppa marol phangkhi. Smt. Pinky gi waphamgi matung inna mahakki mapa Vijay Pal Singh ga machin-manao oiriba Braj Pal gi marakta yeknaba mityeng leirammi. Braj Pal gi michangda atoppa machin-manao oiriba Indra Pal gi machanupasu yaorammi. Adugisu mathakta yumlonnariba Mukesh kasu yu thakminnabagi waapham amadagi yeknaba wapham leirammi. Smt. Pinky masamak mama-mapa ga ground floor da tumlammi. Mache Ms. Rashmi, matei Mangal Singh amasung mabung/moupua Nishant mathak thangba floorda tumlammi. Ayukki pung 3.00 rom tabada minin taaduna houglakpada yumlonnariba Mukesh, Tungal Singh gi macha nupa, Braj Pal Singh, Ravi, Ajai alias Aju na mama-mapabu thaang-ta sijinnaduna asok-apan thokhallammi. Mukesh na

nahakpusi thaang sijinaduna asok-apan thokhallammi. Mahak mapunsi kannaba kanna hotnarammi, sokpagi maramna leimaida taaduna leirammi. Mukesh na, "Abrar, kana amata hingna thaaba yaade, loinamak hatlamgadabani" haina haiba waaphamsu mahakna taakhi. Adugi matungda Mukesh mathakta kaakhi. Mahak aki-pakhatpaga loinana mamagi nakanda taaduna leikhi. Adugi matungda mahaksu siraboi ningduna makhoi yumdu thaaduktuna chatkhi. Makhoina Pramod kouba ming amasu pallamba Pinky na taakhi. Abrar amadi Pramod Noorpur kouba Mukesh ki nupigi mapam oiriba khunggangdagini. Abrar amadi Pramod Mukesh ki yumda toina laakpagi maramna mahakna masak khangba misigni. Mihatpasingna chatkhraba matungda Ms. Rashmi na mathaktagi kumtharabada mama-mapa, mabung/moupua amasung mapuroibagi asiba hakchang ukhi. Makhoi anina kiraduna lao-khong touduna thoklakpada Braj Pal, Mukesh amasung mioi atoppa kharana kari tourabano hanglakhi. Hanglariba makhoina yum changlaga yengluba matamda asiba hakchangsingdu urammi, aduga Smt. Pinky da kanana tourabano haina hanglammi. Akibana thalladuna kanana thouong sing asi toukhibano haibadu khangde, ude haina Ms. Rashmi amadi Smt. Pinky na khumkhi. Makha tarakpada Mukesh na Ajai alias Aiju da gari purakhallaga Ms. Rashmi amadi Smt. Pinky bu hospital da pukhi. Lambida amuk hanna Mukesh na makhoi anida kanana thouong sing asi toukhibano haina hangkhi adubu makhoina khangde haina khumkhi. Smt. Pinky na Investigating Officer na wahang-paokhum tourabada thokkhiba thoudoksing marik chumna likhi. Mache/manaonupi amasung mahakpusu hatnaba thousil sillakan haiba achetpa thajaba leikhbagi maramna Investigating Officerda mihatpasinggi matangda mahakna haikhibasingdu phongdokpidanaba haijakhi. Wari liba loisillabada Smt. Pinky waanthakhi. Ms. Rashmi nasu Smt. Pinky na piba paodamga maannaba paodam Investigating Officer da pikhi; adumoinamakpu court tadi mangonda wahang-paokhum toukhide. Thoudok adugi akuppa paodam louraba matungda Investigating Officer na toupham thokpa makha chatthagadaba thabaksing toukhibaga loinana asiba hakchangsing post-mortem gi thakhi. Adugisi mathakta mathakthongbasingda pigadaba paodamsing piraduna thoudok thokliba maphamda chatthagadaba thouramsing sinduna case siga mari leinagadaba pot-chei sing loukhatkhi.

(2) Oi thangba makha thangba ngaksam da 8 cm. naakonggi makhada 7 cm. x 3 cm. muscle amasung soft tissue da thangpham lei.

Vijay Pal Singh gi macha nupi ani, haibadi, Smt Pinky and Ms Rashmi dagi waarol louraba matungda Investigating Officer Sub-Inspector Ram Babu Saxena (PW-9) na leikhidraba Nishant ki no. 9336780542 sijinaba mobile phone su thiba phangdre haiba waapham isinkhi. Matung taarakpada Investigating Officerna Mukesh amadi Braj Pal Singh bu phaakhi. Mukesh na mihat-mipul aduda saruk yaakhi haibagi waapham thamlaba matungda mahakki mayumdagai ee teiraba khonggrao amasung thaang loukhattuna custody da puraga sealed toukhibaga loinana memo semkhi. Mihiat-mipunda chennariba Abrargisu motorcycle su custody da purakkhi. Braj Pal Singh nasu mihiat-mipul aduda saruk yaakhi haibagi waapham thamlaba matungda mahakki mayumdagai ee teiraba singjang maanba atenba khutlai phangduna custody da puraga sealed toukhibaga loinana memo semkhi. 28.08.2007 da mihiat-mipulda chennaba atoppa mioi Ravi su phaakhi. Maanasu mihiat-mipul aduda saruk yaakhi haibagi waapham thamlaba matungda mahakna phongdorakpagi matung inna mandomchagi yumdagai ee teiraba phurit amasung mobile number 9336780542 haapa LG Reliance mobile phone phaagattuna custody da puraga sealed toukhibaga loinana memo semkhi. 4.11.2007 ta Ajai alias Aju su phaakhi. Maanasu mihiat-mipul aduda saruk yaakhi haibagi waapham thamlaba matungda mahakna phongdorakpagi matung inna thoudok aduda sijinakhiba thang mahakna khunggangdugi turel mapanda lottuna thamba phaagattuna custody da puraga sealed

toukhibaga loinana memo semkhi. Phaagatkhiba khutchu-khutlai amasung potlamsing adu forensic examinationidamak Vidhi Vigyan Prayogshala, Agra da thaakhi.

9. Investigation loiraba matungda chennariba mioi 4 haibadi Braj Pal Singh, Mukesh, Ravi amasung Ajai alias Ajju ki mayokta charge-sheet filed toukhi. Mukesh amasung Ajai alias Ajju ki mayokta sections 4/25 of the Arms Act ki makhada cases 2 pankhi. FIRs 2 ga loinana charge-sheet thaajinduna mari leinaba waaphamsing punsinduna Trial Court ta pukhatkhi.

10. Trial Court tuda mioi 13 koukhattuna wahang-paokhum toukhi. Wahang-paokhum aduda prosecution da puthokliba waaphamdua ayetpa leikhidabaga loinana prosecutiongi matung inna darker leiba potlam amasung che-changnachingbada ayetpa amata leikhide.

11. Criminal Procedure Code2 gi section 313 gi matung inna chennariba mioi 4 dunasu makhoigi waapham thamkhi, madudi makhoibu seraannana maral sinjinbani haikhi. Adugisu mathakta phaagatkhiba potlamsingdu mihat-mipulduda sijinnakhibasing natte su haikhi. Sakhi pikhibasing adusu yekna-mityeng yengbagi maramna seraannaba sakhi pibani haiba waapham makhoi marina thamkhi. Sarvoday Hospitalda puba Dr. Islamuddin (DW-1) bu Smt. Pinky hospital duda laikannakhi haiba sakhi pinaba waahang-paokhum toukhi. Aduga Mool Chandgi nupi, Smt Berwati, Ajai alias Ajju kina mama oiribi (DW-2) oina waahang-paokhum toukhi. Smt. Berwatigi waaphamgi matung inna machanupa Ajai alias Ajju Mukesh amasung Braj Palga loinana phaakhraba matungda Ajai alias Ajju thadorakkhi. Adubu numit 20gi matungda mahak amukka phaakhi haiba waaphamsu thamkhi.

12. Mihat-mipul adugi thoudokki paodam, phagatlabo khutchu-khutlai amasung sakhisinggi paodam kupna yengsillaba matungda tang 24.09.2009 da Trial Courtki warep pikhi. Madudi mihat-mipulduda chennariba mioi marisimakna makhoigi mari-matasu oiriba thoudok aduda leikhidraba mioi maridu hatkhibani aduga Smt. Pinky (PW-1) busu hatke toukhibani. Aduna section 302/149, IPCgi section 307 amadi IPC ga Arms Act, 1959ga mari leinaba aingi waangmagi thouongsing chattharubagi maramna sibagi dandi, punsi chuppa keisumsangda thambagi dandi aduga asisingsidagi hanthaba dandi phanggadabani haina warep loukhi.

13. Trial Court na Sibagi dandi laothokpadugi mayokta dandi phanggadouriba makhoi mari na dandi hanthanaba High Court ta wakatlakkhi. Wakatlakliba Braj Pal, Ajai alias Ajju amadi Ravi na tongan-tonganba counsels sijinnakhi. Adubu Mukesh pudi legal aid tagi amicus curiae sijinnakhi. High Court pukhatlakliba wakat, warol amasung record ta leiriba waaphamsing, Trial Courtna warep loukhibagi maramsingda ayetpa leitabaga loinana kupthana neinaraba, khantharaba matungda law gi matung inna ngakpiheibayaba jaga yenglaga Trial Court na sibagi dandi pikhibasu punsi chuppa keisumsangda leibagi dandi oina pinaba warep loukhi.

14. Thoudoksigi maramna awa-ana taariba wakatmising Court sida leiri.

15. Party animakki learned counselsinggi waapham mapung phaana taaraba amasung learned counselsingna case asiga mari leinaraba sakhi amadi potlamsing puthokpasu kupthana Court sina neinaba khak nattana Trial Court na case asigi ahoubadagi thamba achumba waarolsing taare.

16. Wakatmisinggi mahut sinduna waapham amadi waarolsing puthoktuna makha tana Khanna neinabagi waarolsing makhatana piri.

i) Case asida mitna uba sakhi piriri Smt Pinky (PW-1) asi leikhidraba mioi marisiga yaamna naknaba marini. Adugisu mathakta mahaksi wakatlakliba mioisingsiga yeknaba waakhallon leiba mini. Aduna mahakna sakhi oina piba paodamda thajaningai leite.

ii) PW-1 gi sakhi amasung paodamsi nattana case asiga mari leinaba atoppa paodam amata leite.

iii) Smt Pinky (PW-1) na thoudok adu hek thokpa matung lao-khongba matamda khungganggi mina amasung mari-matasingna hanglaba matamda mihatpa kanano haiba waapham thamkhide. Adugisu mathakta mahakpu hospitalda admit touba matamdasu mihatpa kanano haiba waapham thamkhide. Aduna case asida sakhigi waaphamda hongdok-hongjin lei.

iv) Thoudok thokliba numittugi ayukta huigi squad sijinaduna thidin humjin chatthakhi aduga sakhi oi hairiba Smt Pinky (PW-1) na mihatpa ukhiba amasung khangkhiba leite. Huigi squad sijinaribasi mihatpa masak khangdabagi maramnani. Aduna case asida sakhibi waaphamda hongdok-hongjin lei.

v) Mihat-mipulgi thoudok thokpa matamda thokliba yumduda leiramba Ms Rashmi amadi leikhidraba Vijay Pal Singh, Braj Pal gi mapa oiriba aduga Ravigina mapubok oiriba Horam, makhoi anibu waahang-paokhum toudabagi maram pikhiba leite.

vi) Smt Pinky (PW-1) na pikhiba paodam amasung waaphamsing section 164 CrPC gi matung inna Magistrateki mamaangda thamkhiba leitabana chingnaningai oihalli.

vii) Section 161 CrPC gi matung inna Smt Pinky (PW-1) na Investigating Officergi mamaangda mihat-mipulsi kanana thokhankhibano haiba phongdokkhiba leite haina wakatmi Ravi gi Learned counsel na phongdokkhi. Adugisu mathakta Ravigi ming asi trialda ahaanba oina puthorakkhibasi hongdok-hongjin touba waaphamni haikhi. Mahakki client pu maram chadana casesida pusinbani haina phongdokkhi.

Nakan amadana respondentki learned counsel oiribagi matung inna State na thamkhiba warepsing asi Trial Court amadi High Court na kupthana amasung mapung phaana case asiga mari leinaba waapham amasung potlamsing thijinduna, sijinnaduna neinaraba matungda taakhiba warep loubagi maramna taakhiba waarep asida onthok-onsin nattraga makha taabagi maram leite haina phongdokkhi. Learned Counsel na makha tana phongdokkhi, madudi wakatlakliba mioising asi leikhidraba misingga anakpa mari oibagi maramna lam-tu munningbagi aduga laman khumningbagi maramna tamthiraba mihat hatpakhat nattana sakhi oiriba Smt Pinky (PW-1) busu haatnaba hotnaduna nangakta thaang-ta sijinaduna sokhanba, khutsa maton kakthatpagi thouramsing pangthokkhibani. Makhoigi tamthiraba matou asi yenglaga ngaakpinaba maram leite haina makha taakhi. High Court na sibagi dandi bu punsi chuppa keisumsangda leihanbagi dandida onthokpasu chumde aduna High Court na punsi chuppa keisumsangda leihanbagi dandi haiba waaphamsi naakanda thamduna Trial Court na pirakkhiba sibagi dandisimak warep oipham thok-e haina phongdokkhi.

18. Paodamsing asida aonba leitana makha taana neinakhi. Haibadi, PW-1 asi thoudok aduda hinghouba sotkuna leiba sakhini. Mahakki asok-apangi maramda wahang-paodam atoppa leite. Aduna PW-1 na piba paodamda araanba, chingnaningai oiba leite. Mahakki paodamsingda kupthana yenglaba matungda prosecution na section 161 CrPC gi makhada thoudok adugi loukhatpa waaphamga chaanei. Cross-examination touba matamdasu waaphamsingsida aonba, khetnaba natraga case sonthahanba yaaba waapham leikhide. Aduna PW-1 asi thajaba yaaba sakhi oikhibakhak natana mahakki waaphamsing si tasengna thokkhiba thoudoktugi warini haina phongdokhi.

19. Leikhidraba Vijay Pal Singhgi macha nupi anina mihat-mipul ubakhak nattana masamaksu asok-apan kaya thengnarabatungda ahanba khongphamjadi mihat-mipuldu kanana toubano haikhide. Madu masa kanjanaba mihatpasingdugi mamaangda achumba waapham phumjinkhibani. Adumoinamakpu Investigating Officerna hospitalda waahang-paokhum ahanba touba mikuptagi Smt Pinky (PW-1) na achumba waarolga loinana mihat-mipuldu kanana toukhino haibadu marik chumna phongdokpaga loinana thoudoktugi mathang manao naiba thouongsing adu likhi. Maram oiduna wakatlaklibasingda khudong chaba karigumba amata pinigai leite.

20. Thoudok thokpa ayuktuda huigi squad sijinnakhbadusu maram chai maramdi mihat-mipul touriba misingga maming matha FIR panba matamda haikhiba, pikhiba leite. Prosecution matung innasu FIR panba matamda amasung Smt Pinky (PW-1) bu hospital da pukhiba matam phaobada mihat-mipul touriba misingga maming matha pankhide aduga pankhidabagi maramsu chai. Leikhidraba Vijay Pal Singhgi macha nupisingna mapunsi kannaba misak takkhidabani, natragadi makhoisu siramlaba yai.

21. Ms Rashmi amadi Vijay Pal Singhgi mapa Horam bu waahang-paokhum toukhidabasu akaiba leite maramdi prosecutionna darkar oibagi matung inna sakhi amasung paodam masing hengatke hengatloi haiba yai. Sakhi masing hengatpana achumba sakpa yaade adubu sakhidugi achumba waarolduni darkar oiribadi. Smt Pinky (PW-

1) si masasu thoudoktuda soklabi aduga siba yaaba phibamda awa-ana nanglabi sakhini. Aduna case asigi Trial Courtna pikhiba waarepta aonba leipham thokte haiba waapham learned counselna thamkhi.

22. Section 164 CrPC gi makhada leiba paodam waaphambu yengsindabana courts ki warepta chaanadaba leite. Section 164 CrPC gi makhada paodam waapham loubadi Investigating Officergi daita ni. Karigumba Investigating Officer duna Section 164 CrPC gi makhada paodam waapham louba darkar leite khallabadi PW-1 ni piba paodam-waapham amasung trial duda case ka mari leinaba pot-chei puthokpasinggi kaanapham leite.

23. Ravigi learned counselgi matung inna Smt. Pinky section 161 CrPC gi waphaam-paodam pibada Ravigi ming pankhide haibasi araanba waaphamni. Courtna Smt Pinkygi waaphamsing neinabada Ravigi ming thoudoktuga mari leinana anirak pankhiba yaoe.

24. Wakatmi Mukeshki Learned Amicus sakhi amasung paodamsingda araanba kaya yaoe haiba waapham thamkhi. Adumoinamakpu waaphamsingdu casesigi warepta khetnaba leibagi machak oidabagi maramna hairibasingduda kupthaba darkar oide haina Courtna haikhi.

25. Mathakta phongdokkhraba waaphamsingsina maram oiraga High Courtna piriba yaathangsida wakatmisinggi maralda waatthahanba yaaba amata leite. Aduna maram oiduna 2013gi Criminal Appeal Nos. 598-600 amasung 2014gi Criminal Appeal No. 337 animak dismissed toukhre. Statena cheirap hengatnaba file touba wakatkimatangda High Court na sibagi dandidagi punshi chuppa keisumsangda thambagi dandi da onthokpasigi achetpa maramsing marik chumna pibagi matung inna 2015gi Criminal Appeal Nos.745-748 su dismissed. Wakatmising adumak custody leiduna phangpham thokpa dandi phanggadanabi.
