WP (C) No. 448 of 2014 da mai pakkhidraba petitioner aduna mahakki writ petition adubu kakthatkhiba tarik 22-06-2017 da takhiba order aduda pendraduna, writ appeal No. 5 of 2019 asi tharakhibani. Adubu, appeal asi tharakpa numit 555 thengthakhiba leibana, asumna thengthakhiba adu ngakpinaba mahakna MC (WA) No. 4 of 2019 asi tharakhibani. Adum oinamak, adu thangatlapa matamda numit 555 ni chonthakhiba adugidamakta mahakna MC (WA) No. 4 of 2019 gi khuthangda ngakpinaba haijakhi.

Applicant/appellant ki mahut sinduna lepliba learned senior counsel, N. Jotendro na mahut sinduna lepliba learned Government Advocate S. Napolean amadi respondent No. 5 dagi 44 faobagi mahut sinduna lepliba learned senior counsel N. Ibotombi na haibusu tare.

Hairiba writ petition asida yaoriba mahakki pendaba wakatti asini madudi applicant/appellant asibu Manipur Veterinary and Animal Husbandry Service Grade-III da pham wangkhatpidre/promotion pibidre, adubu mahakki makha taba (juniors) singbuna eng 2014 ki February tha da hairiba pham aduda promotion asimak pikhere haibasini. Hairiba pham asigi mingtholsi 'Specialist' hairi aduga promotion adu mangonda pikhidabasi mahakki annual confidential reportsing (ACR sing) da applicant/appellant na fangkhiba grading sing adu nembanani.

Appeal asi tharakpada numit 555 thengthakhibagi applicant/appellant na piriba maramdi asini madudi mahakki machasing adu China da mahei-masing tambagi thabada sel yamma changkhivana mahak selgi oiba awaba mayoknakhi amadi Right to Information, 2005 ki makhada mahakki ACR singga mari leinaba che-changsing mahakna tasin khomjindaba leiba, pumnamak asina maram oiraga, changkhiva matam adu mahakki shaktigi wangmada leikhi.

Applicant/appellant asina thabak touringei matamda mahakki ACRs ki copysing keidoungeidasu pirakhiba leite; maram aduna mahakki promotion phangbada achouba ayetpa ama oikhiba masagi ACRs gi gradingsing khangjanabagi upai amatta leikhide haina learned senior counsel, Mr. N. Jotendro na phongdokhi. Adum oinamak, applicant/appellantna service ta leiringei manungda kari maramgi mahakki ACR sing adu fhangnaba hotnakhidabano haibagi maram chaba amata thamkhide. Masi oidunasu, mamangda pankhibagumna, applicant/appellant asina shingnariba promotion asi houkhiba eng 2014 gini, adugi mathakta mahak masamaksi yamma kuirabagi mamangda thabaktagi pothakhraba meeshak amani. Maram aduna, matang asida mahakna mahakki pensionda ahenba khudokchaba fhangbagidamak mahakki promotion asi hangatlagha pibiyu hairiba asi yapham thokte. Maikei khudingdagi yenglabsu, applicant/appellant asina touriba thouwong asi oirodaba/honglaroidaba waapham amada kanadabana matam manghanbani haina louwi.
